**AN ORDINANCE PROVIDING FOR THE LEVY AND ASSESSMENT
OF TAXES FOR VILLAGE OF OAK PARK
SPECIAL SERVICE AREA NUMBER ONE FOR
THE FISCAL YEAR BEGINNING JANUARY 1, 2008 AND ENDING
DECEMBER 31, 2008, AND REPEALING ORDINANCE NO. 2008-O-61
ADOPTED DECEMBER 2, 2008 IN RELATION THERETO**

BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, as follows:

SECTION 1: Findings. Village of Oak Park Special Service Area Number One has been created/reestablished pursuant to Ordinance No. 2007-O-62:

**“AN ORDINANCE REESTABLISHING VILLAGE OF OAK PARK
SPECIAL SERVICE AREA NUMBER ONE WITH ALTERED
BOUNDARIES AND THEREBY EXTENDING THE EFFECTIVE
PERIOD FOR A PROPERTY TAX OF THREE PERCENT OF
EQUALIZED ASSESSED VALUE IN RELATION THEREOF”**

adopted December 13, 2007 and effective as of December 14, 2007, no valid petition containing the signatures of fifty-one percent (51%) or more of the electors (registered voters) and fifty-one percent (51%) or more of the owners, having been filed opposing the creation of the Special Service Area, pursuant to Chapter 35, Illinois Compiled Statutes, Act 200, Section 27-55. Said Special Service Area Number One consists of the territory described in the ordinance aforesaid. The Village of Oak Park is now authorized to levy taxes for special services in said Special Service Area.

SECTION 2: That the total amount of appropriations for all purposes to be collected in part from the tax levy for the current fiscal year in Special Service Area Number One is ascertained to be the sum of \$204,447.00.

SECTION 3: That the following sums be, and the same hereby are, levied on the taxable property of Special Service Area Number One for the fiscal period beginning January 1, 2008 and ending December 31, 2008:

SECTION 4: This tax is levied pursuant to Article VII, Section 6 of the Constitution of the State of Illinois; Chapter 35, Illinois Compiled Statutes, Act 200, et seq., and in particular Sections 27-5 through 27-85 thereof, and pursuant to an Ordinance Reestablishing Village of Oak Park Special Service Area Number One, also known as Ordinance No. 2007-O-62.

SECTION 5: That there is hereby certified to the County Clerk of Cook County, Illinois, the sum aforesaid, constituting said total amount of \$204,447.00, which said total amount the Village of Oak Park Special Service Area Number One requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby ordered and directed to file a certified copy of this Ordinance with the Cook County Clerk, on or before December 30, 2008.

SECTION 6: That Ordinance No. 2008-O-61, adopted December 2, 2008 and filed with the County Clerk's Office on December 5, 2008, is hereby repealed.

SECTION 7: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
