

## Pay by phone parking arrives

**P**aying for parking in any of more than 4,000 public spaces throughout the Village will get a lot more convenient come Oct. 7, as Oak Park launches a new program that accepts payment via a smartphone app or toll-free telephone call.



The new service is provided by PassportParking, an industry leader in integrated cloud-based parking solutions. The system allows for a more user-friendly, cashless payment option, as well as for more effective and efficient parking management and enforcement operations.

To use the system, customers register via the free PassportParking Mobile Pay app or voice telephone system. The app is available for both iPhone and Android users. Simple registration instructions are conveniently located near each parking site.

Once securely registered, motorists can use the mobile payment option with the app, call a toll-free number or text the zone and space information posted at the parking site. A valid credit card is required to use the system and a 35-cent fee is levied for the initial transaction.

Motorists also can choose to receive text message reminders 15 minutes prior to the expiration of their parking session and extend the time remotely.

In addition, drivers who use the mobile pay technology also will be able to log in using a Facebook account to find nearby businesses that offer validation or other discounts.

Passport's mobile payment services already are available for public parking in the Illinois communities of Brookfield, Desplaines, Downers Grove, Glenview, Harvard, Morton Grove, Oak Lawn and Villa Park, as well as in privately owned parking facilities in several major cities including Atlanta, St. Louis and Salt Lake City.

**R**esidents selected to take a community survey who have not yet returned the document are urged to do so as soon as possible. Surveys were mailed in early September to addresses chosen randomly. About 1,200 responses are needed for a 95 percent confidence level. Respondents remain anonymous. While taking only about 15 minutes to complete, the surveys will help policy makers better understand priorities for government action and citizen opinions on quality of life and public services. # Speak out against distracted driving



**H**ave you ever been stopped at a traffic signal that turns green, but the car in front of you doesn't proceed until you blow your horn? Ever had a driver make a turn without signaling? Ever seen a vehicle do less than the speed limit, while swerving ever so slightly?

If you answered yes to any of these questions, chances are you were behind a distracted driver.

Eating, drinking, talking to passengers, grooming, reading (including maps), using a navigation system, watching a video and adjusting a radio, CD player or MP3 player all are dangerous distractions. But text messaging requires visual, manual and cognitive attention from the driver and is by far the most dangerous distraction.

Studies have shown that sending or receiving a text takes a driver's eyes from the road for an average of 4.6 seconds. That's the equivalent of driving a vehicle 55 miles per hour the entire length of a football field – with your eyes closed.

In 2011, more than 3,300 people were killed in crashes involving distracted drivers. Another 387,000 people were injured, many of them seriously. And the numbers of deaths and injuries are growing each year.

The issue of distracted driving is a complex one, given the extent to which our lives have become intertwined with our mobile devices. But the risk is real. Unfortunately, public education and enforcement of traffic safety rules are

not enough to stop such risky behavior.

Personal responsibility is the best defense against potentially lethal behavior behind the wheel. Everyone needs to understand the risks of driving distracted and recognize their own inability to safely multi-task while behind the wheel. This means putting wireless devices away and keeping your eyes on the road.

Friends and family members also need to use their influence to steer others toward responsible driving behavior. Just speaking up may save a life.

For a vivid, eye-opening example of lives touched by the actions of a distracted driver, I urge all Oak Park cable subscribers to watch VOP-TV on Comcast channel 6 and AT&T Uverse channel 99 at 6:30 p.m. on Tuesdays, Thursdays and Saturdays. Perhaps after watching the video *Red Means Stop*, we will re-think some of our behaviors behind the wheel.

**H**ere's what is coming up in October at the Oak Park Conservatory, 615 Garfield St.:

**Columbus Day Hours** – The Oak Park Conservatory will be open from 10 a.m. to 2 p.m., on Columbus Day, Mon. Oct. 14. The Exploration Station will be open until noon allowing youngsters to touch and smell various plants.

**About the conservatory** – Owned and operated by the Park District of Oak Park, the Conservatory is one of the top three historical sites in the Village, attracting 30,000 visitors annually. Staff and volunteers grow an astounding 20,000 bedding plants from seeds and cuttings that are planted each year at 90 public



parks and sites throughout the village. The Edwardian-style glass structure, built in 1929, houses a botanical collection of more than 3,000 plants, some of which date back to the Conservatory's founding. The Conservatory was named to the National Register of Historic Places in 2005.

## Fall leaf collection begins this month

The annual fall leaf collection program is scheduled for Oct. 21 – Dec. 5 with seven pickups planned for each section of the Village. Residents should rake leaves into the street at least 18 inches from the curb the day before the scheduled pickup dates indicated on the map. Leaves raked into the street are pushed into piles during the night, and then collected the following day. Residents who miss a scheduled pickup date should keep their leaves on the parkway until the night before the next scheduled pickup. Sweepers will be scheduled to run at the end of the collection program to clean up any residue. Cooperation is essential to the success of this operation, so please follow these simple rules:

- Rake leaves out the day before the scheduled pickup date.
- Leaves only — do not add brush, grass clippings or yard waste.
- Do not park on or near a pile of leaves, which can hinder leaf removal operations. Heat from a car also could ignite the leaves.
- Rake leaves onto side streets whenever possible. Try to avoid major thoroughfares where piles of leaves might create traffic hazards.
- Do not rake leaves into or close to cul de sacs or traffic diverters. The equipment needs room to operate.
- Keep catch basins clear of raked leaves to avoid flooding.
- Inform landscape services of the leaf collection schedule.
- Obey all parking restrictions. Regulations will be strictly enforced.
- Dampen piles after raking to avoid leaves being blown by the wind.
- Consider composting or using the leaves as garden mulch as an alternative to raking.
- Drive carefully. Leaves are slippery when wet and large piles may hinder visibility. Watch for crews picking up leaves.

## October means time for a flu shot

The Centers for Disease Control recommends inoculation for influenza as soon as the vaccine becomes available since flu seasons are unpredictable and can begin as early as October. Everyone should get a flu vaccine beginning by age 6 months, officials say, especially individuals who have medical conditions such as asthma, diabetes and chronic lung disease. Pregnant women and individuals 65 years and older also should be vaccinated, as well as people who live with or care for others who are at high risk of developing serious complications. Parents of infants under age 2 are encouraged to contact the child's physician to arrange for flu vaccinations. Flu vaccine is offered at numerous commercial pharmacies, grocery stores and other retail sites in the Oak Park area. Most of these sites accept private insurances and Medicare Part B to help cover the cost of the shot. Many sites will vaccinate children as young as 18 months. Medicare HMO recipients should check with their insurer before scheduling an appointment. ## EPA recognizes Village green-energy efforts

For the second year in a row, the use of green power through the Village's *Community Choice Electricity Aggregation Program* has earned Oak Park special recognition from the U.S. Environmental Protection Agency.

The USEPA recognized Oak Park as one of only two communities selected from among nearly 50 participating communities nationwide for a Green Power Community (GPC) Challenge award for having the highest green power percentage of total electricity use.

Launched in September 2012, the GPC competition challenges communities to boost their voluntary green power usage and compete to see which one can use the most green power and achieve the highest green power percentage of total electricity use.

The purchase of green power not only helps the Village become more sustainable, but also sends a message to other communities across the U.S. that supporting clean sources of electricity is a sound business decision and an important choice in reducing climate risk, officials say.

More than 90 percent of electricity used by Oak Park's local government, residential and business electricity users comes from renewable power sources. According to EPA, Oak Park's collective use of more than 170 million kilowatt-hours (kWh) of green power is equal to avoiding the carbon dioxide (CO2) emissions of more than 25,000 passenger vehicles per year, or the equivalent of the electricity needed to power more than 18,000 homes annually.

Green power is electricity generated from renewable sources like solar, wind, and low-impact hydropower. Communities using green power benefit from cleaner air and a healthier environment, while helping advance the market for renewable energy, EPA officials say.

The nearly 50 Green Power Communities across the country collectively buy green power in amounts that meet or exceed the EPA's purchase requirements as part of the Green Power Partnership. Other participating Illinois communities include Aurora and Rolling Meadows.

Last year, the USEPA also named Oak Park a *Green Power Community of the Year* for its electricity aggregation program that purchases power and credits from 100-percent green sources, primarily from Illinois wind farms.
