

MEETING MINUTES CITIZEN INVOLVEMENT COMMISSION WEDNESDAY, MARCH 5, 2025, 7:00 P.M. VILLAGE HALL, ROOM 101

A. Call to Order

Chair Kolar called the regular meeting to order at 7:02 P.M.

B. Roll Call

William Obuchowski is an attorney who deals with insurance contracts and coverage. He grew up in Oak Lawn and his wife grew up in River Forest and teaches at OPRF. He sees this as an opportunity to learn more about what is going on in the community and meet more people. He is excited about the Earth Day events coming up. He said he is flexible if he is needed on another commission.

Mike Nickels grew up in River Forest and went to OPRF. He runs his own business doing energy efficiency work for multi-family properties. He is a GC and mechanical contractor specializing in heat pumps and a licensed electrician. He has done zoning reviews. He moved back to Oak Park three years ago and sees needs and ways he can support and be connected through community involvement.

Jonathan Skinner has been an Oak Park resident since 2022. He recently got citizenship. He is interested to get involved with the Village from a civic point of view. He has 15+ years of experience in IT. He is an engineer with Apple and works in the enterprise world and is used to projects that take years to complete. He is particularly interested in open data.

Wayne Huang has been an Oak Park resident since 2020. Spent 17 years working in technology and then 8 years working in IT audit and data analytics. He and his wife volunteer at their church and want to become more involved in the community. He works for CF Industries, a chemical manufacturer that specializes in ammonias and fertilizers. He would also be interested in the Historic Preservation Commission.
