**SUBJECT:** Pedestrian (Field) Stop Data – 2025 First Quarter

# **Purpose**

The purpose of this memorandum is to provide data on the pedestrian/field stops for the first quarter of 2025.

## Background

There were 94 field stops: 74 were Calls for Service (CFS) and 20 were Self-Initiated Stops (SI), resulting in 17 arrests. Below is the summary of data for each month and attached is a PowerPoint with the details of each stop.

In **January**, there were 26 pedestrian stops in response to 20 incidents, with multiple individuals stopped for 3 CFS. Additionally, seven arrests were made:

- 2 Suspicious Activity/Incident
- 1 Suspicious Auto
- 2 Trespass
- 1 Panhandling
- 5 Other usually related to criminal activity CFS

In **February**, there were 34 pedestrian stops in response to 26 incidents, with multiple individuals stopped for 4 CFS. Additionally, seven arrests were made:

- 14 Suspicious Person
- 4 Suspicious Activity/Incident
- 2 Suspicious Auto
- 14 Trespass

- 10 M/W (7 juveniles)
- 13 M/B
- 1 F/W
- 8 F/B
- 2 M/H (2 juveniles)

In **March**, there were 34 pedestrian stops in response to 29 incidents, with multiple individuals stopped for three CFS. Additionally, four arrests were made:

- 13 Suspicious Person
- 4 Suspicious Activity/Incident
- 8 Suspicious Auto
- 3 Trespass
- 6 Other usually related to criminal activity CFS
