



COVID-19 Public Health AMENDMENT TO COVID-19 PHASE 4 MITIGATION ORDER

Pursuant to Village of Oak Park Resolution 20-120 dated March 13, 2020, the Oak Park Village Board declared an emergency affecting the public health due to the outbreak of the COVID-19 disease pursuant to Section 8-10-5 of the Illinois Municipal Code, 65 ILCS 5/8-10-5, and Sections 2-6-10, 2-27-9 and 20-1-6(Z) of the Oak Park Village Code through April 6, 2020. Said emergency was extended or reinstated as follows: (1) through May 5, 2020 by Village Resolution 20-124; through June 1, 2020 by Village Resolution 20-128 dated April 27, 2020; (2) reinstated on July 27, 2020 through September 14, 2020 by Village Resolution 20-184; (3) reinstated on November 2, 2020 by Village Resolution 20-232 through February 16, 2021; and (4) extended on January 19, 2021 by Village Resolution 20-43 through June 15, 2021. Pursuant to these resolutions and Section 20-1-6(BB) of the Oak Park Village Code, which was adopted by the Village Board on January 19, 2021 by Ordinance 21-8, the Village's Public Health Director has the authority to make "reasonable rules, regulations and orders . . . as may from time to time be deemed necessary . . . due to the outbreak of COVID-19 disease in the State of Illinois" through June 15, 2021.

AMENDEMENT TO COVID-19 PHASE 4 MITIGATION ORDER

- 1. On February 4, 2021, I issued an Order regarding Phase 4 Mitigation ("Phase 4 Order") requirements applicable in the Village of Oak Park ("Village") pursuant to my authority as the Interim Public Health Director as set forth above.
- 2. I have determined to amend the Phase 4 Order ("Amendment Order") to expand indoor dining capacity for all businesses that offer food or beverages for on-premises consumption, including, but not limited to, restaurants, bars, grocery stores, and food halls.
- 3. Section 3(A) of the Phase 4 Order is deleted and superseded in its entirety and is replaced with the following:
 - 3. Establishments that Serve Alcoholic Liquors, Restaurants, Private Clubs, Country Clubs (All businesses that offer food or beverages for on-premises

consumption—including, but not limited to, restaurants, bars, grocery stores, and food halls):

- A. Indoor service is limited to the lesser of 50 patrons or 50% of capacity per room. The maximum size of any group dining together is six (6) persons.
- 4. Other than as set forth herein, the Phase 4 Order shall remain in full force and effect. If any provision of this Amendment Order is in conflict with a provision of the Phase 4 Order, the provision of this Amendment Order shall control.
- 5. This Amendment Order shall further be in full force and effect until further order.
