COVID-19 Status Report
Oak Park Village Board of Trustees

To: Village President and Village Board of Trustees

The memo is a means to share a brief summary of information regarding Village of Oak Park operational activities in response to COVID-19. In most cases, formal public guidance or employee guidance has been publicly disseminated via the Village website or Village social media channels.

The issuance of the Status Reports will be increased to Mondays, Wednesdays and Fridays in response to the slight uptick during this past seven day period.

New Public Health Guidance

The Village of Oak Park Department of Public Health received notification of the following new COVID-19 cases; since last reported:

Excluding individuals for which street addresses are not yet determined, the State of Illinois reports a total of five-hundred and six (506) total Oak Park COVID-19 cases. It is important to note that as patient tracking and case follow-up occurs, individuals listed within the number of Oak Park cases reported may change depending on residency confirmation.

The Oak Park Department of Public Health is notified of positive tests as established by state and local public health protocol. Because of privacy laws, no additional information can be released about the individuals. It is noted, that privacy precludes location information regarding individuals tested to anyone other than Public Health Officials and First Responders.

The Oak Park Department of Public Health is working closely with officials from the Illinois Department of Public Health (IDPH), investigating and notifying anyone who may have had exposure to the individual who tested positive for COVID-19. Local public health officials, hospitals and first responders are following protocols consistent with the latest guidance from the Centers for Disease Control and Prevention (CDC).

Cases related to Long-Term Care and Assisted Living Facilities

The Oak Park Public Health Department has been consistently reporting cases of residents in Oak Park senior facilities where Assisted Living or skilled nursing care is provided. The Village of Oak Park has five facilities which meet the above definitions (it is noted that some of the Long

Term Care and Assisted Living facilities in Oak Park also have within their property some independent living units.) That data is reported daily in the chart below which today was updated as Public Health Director Charley reported that a staff member at Oak Park Arms, 408 S Oak Park Avenue, has tested positive for COVID-19 which is the 4th staff case.

Additionally, Oak Park has reported on cases in its Independent Senior Living facilities, which function more like an apartment building, but limit access to individual by age and in some cases age and income. These Senior Buildings are not included in the chart. Today, Public Health Director Charley has report a new positive case (the eight since the onset of COVID-19 in the community) at the Heritage House, 201 Lake Street. The facilities first cast was reported on April 18, 2020. The Public Health Director is consulting with the property manager on this matter.

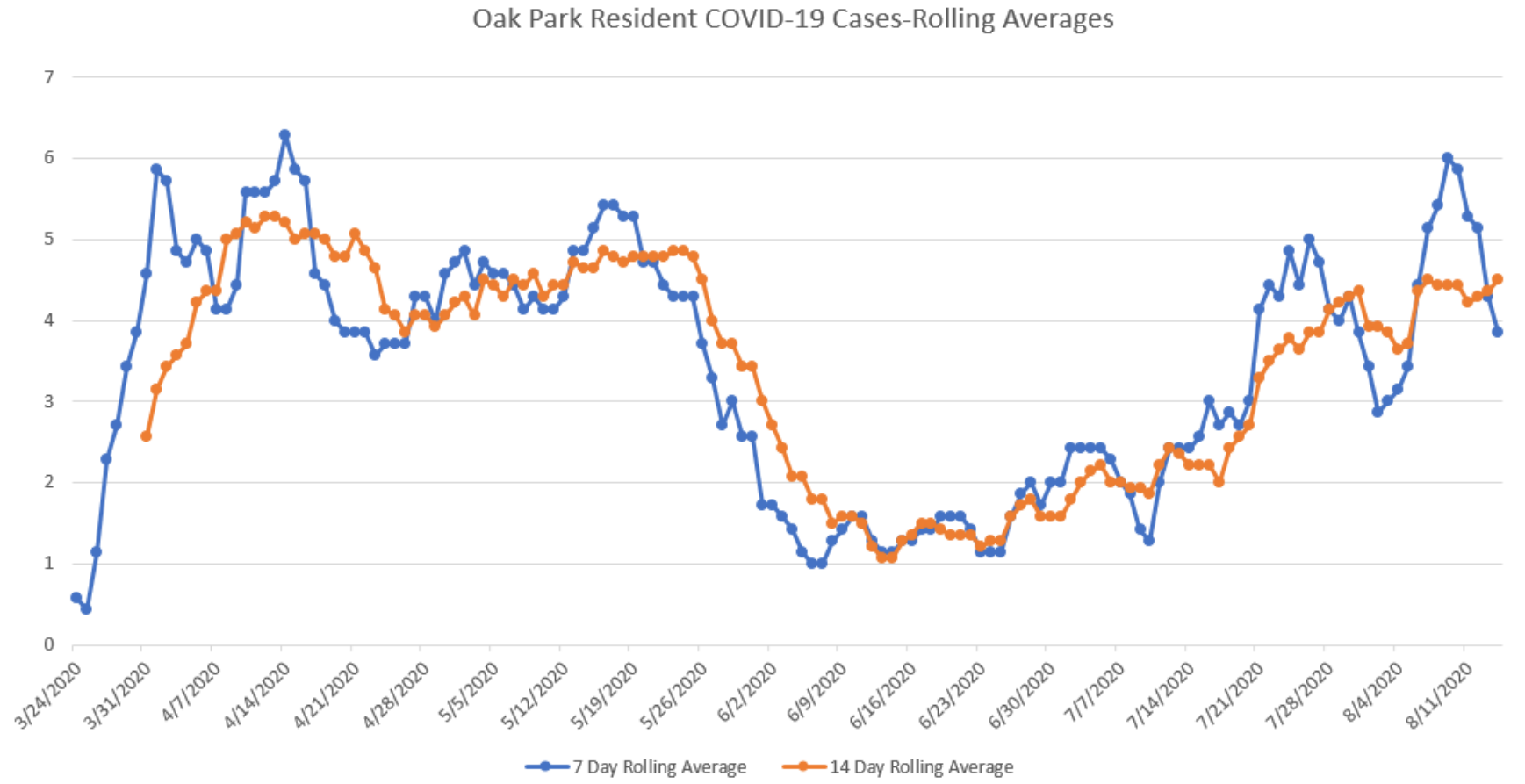

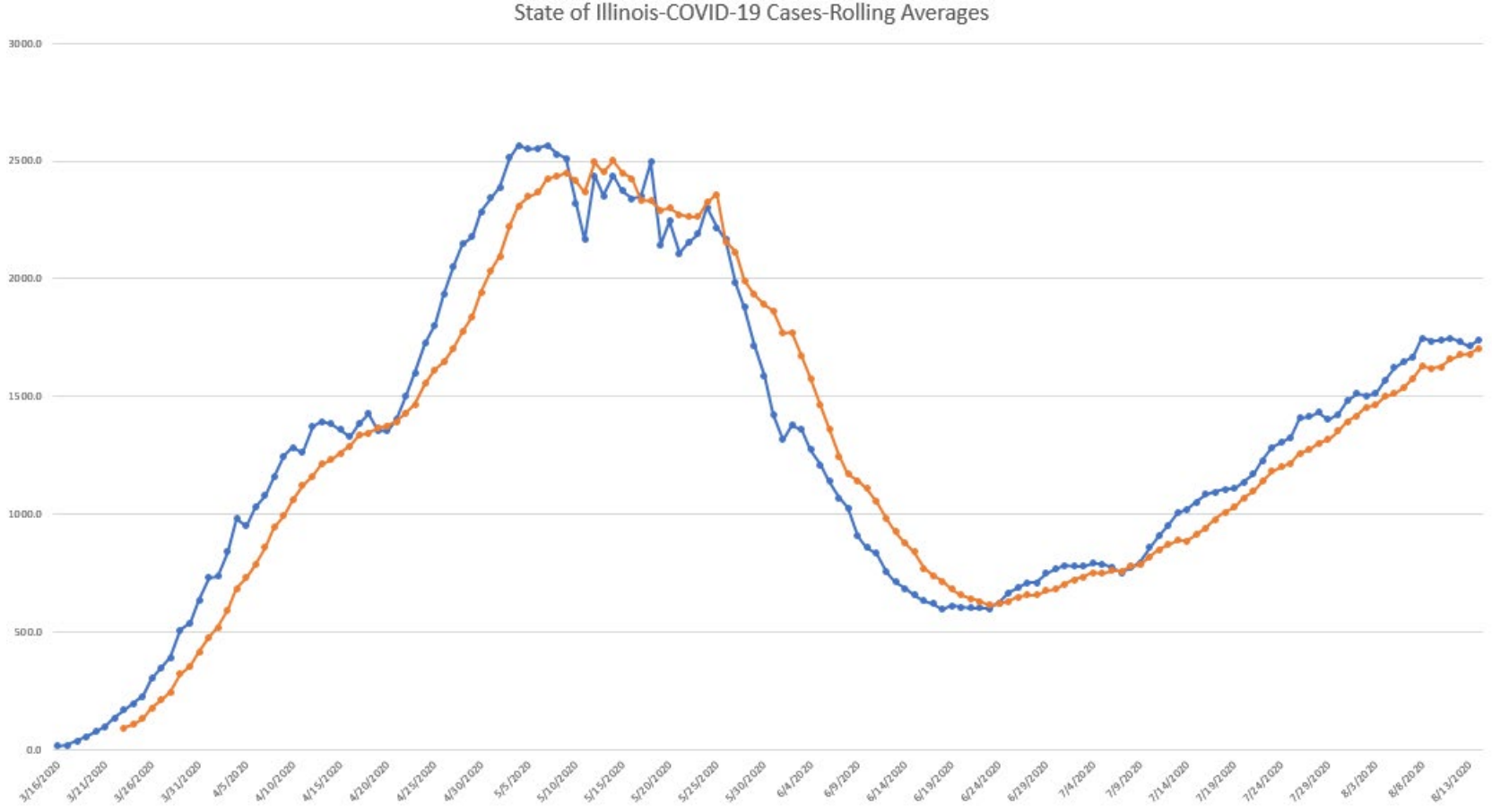
