COVID-19 Status Report Oak Park Village Board of Trustees

To: Village President and Village Board of Trustees

The memo is a means to share a brief summary of information regarding Village of Oak Park operational activities in response to COVID-19. In most cases, formal public guidance or employee guidance has been publicly disseminated via the Village website or Village social media channels.

New Public Health Guidance

The Village of Oak Park Department of Public Health received notification of the following new COVID-19 cases; since last reported:

Excluding individuals for which street addresses are not yet determined, the State of Illinois reports a total of one thousand two hundred and fifteen (1215) total Oak Park COVID-19 cases. It is important to note that as patient tracking and case follow-up occurs, individuals listed within the number of Oak Park cases reported may change depending on residency confirmation.

The Oak Park Department of Public Health is notified of positive tests as established by state and local public health protocol. Because of privacy laws, no additional information can be released about the individuals. It is noted, that privacy precludes location information regarding individuals tested to anyone other than Public Health Officials and First Responders.

The Oak Park Department of Public Health is working closely with officials from the Illinois Department of Public Health (IDPH), investigating and notifying anyone who may have had exposure to the individual who tested positive for COVID-19. Local public health officials, hospitals and first responders are following protocols consistent with the latest guidance from the Centers for Disease Control and Prevention (CDC).

Cases related to Long-Term Care and Assisted Living Facilities

Oak Park Public Health Director Mike Charley reported today two new resident cases and eight new staff member cases at Belmont Village, 1035 Madison along with one new staff member case at Oasis Oak Park, 625 N. Harlem.

Also, Oak Park Public Health Director Mike Charley reported today the thirty-fifth death of an Oak Park resident believed to be related to the COVID-19 coronavirus. The fatality is a 92-year-old

male residing at one of our long-term healthcare facilities. Director Charley expressed his sincere condolences to the resident's friends and family for the loss of their loved one.

Village Employee Tests Positive

The Village had an employee test positive for COVID-19 this week. In accordance with the provisions already in place for COVID-19 positive diagnoses in the workforce, the employee and any others who have had direct close contact with these individuals in the course of their work, was notified and placed in quarantine status. The employee is a sworn officer in the Police Department. Because of privacy laws, no additional information can be released. Because of privacy laws, no additional information can be released. The Village now has had fifteen (15) confirmed cases of COVID-19 in the workforce.

New Emergency Declaration in Oak Park

Last week, on Monday, November 2, 2020, the Village Board approved a resolution *Declaring an Emergency affecting Public Health*. This is similar to the initial emergency declarations approved by the Village Board in March and April and July of this year. This is NOT a stay home order.

Following cessation of the prior Declaration of an emergency affecting public health which ended September 14, 2020, the Village Board was being asked to adopt a new Declaration, a procedural step under state law and the Village Code, to empower municipal administrators to continue to respond more quickly to the recent increase in positive COVID-19 cases in Oak Park.

The adoption of this Declaration is in effect through February 16, 2021 and support staff's continued focus our public health efforts as well as work in support of the economic impact of COVID-19 mitigation measures in the business community such as ongoing use of Village property for outdoor dining as well as temporary zoning waivers to use private parking for outdoor dining at restaurants.

Interim Public Health Director

Sincere appreciation is extended to Public Health Director Mike Charley as he concludes service to the Village of Oak Park after 17 years with an undeniable commitment to the health and safety of all who live and work in Oak Park. During his tenure with the Village, Mike has managed a wide variety of services for the Village of Oak Park including a health assessment with community

partners, health investigations and screenings, community-wide education, prevention services, case management, nursing, counseling, access to other community resources and he has been a leader in the Village's ongoing emergency response to the COVID-19 pandemic. Joseph Terry begins working as Interim Public Health Director on Thursday, November 12, 2020 to ensure continued public health management during this unprecedented time.

Public Health Data

Public Health Director Charley has shared the following data related to COVID-19. "New cases per 100,000 People". This metric looks at the number of recent COVID-19 cases per 100,000 people to describe the potential number of people who are currently ill and may be infectious. This is the number of new cases reported by IDPH in the previous week. Calculated as a rate = [Village of Oak Park case count for 7 days] / [Village population] x100,000.

- Oak Park rate: 288/100,000
- Cook County rate: 342/100,000 (10/25/2020 through 10/31/2020)
- Target for County-level data: Cases for the week are fewer than 10 or the rate is fewer than 50 cases per 100,000 people
- Warning for County-level data: New case rate is greater than 50 cases per 100,000 people




