# **New Public Health Guidance**

Today, the Village of Oak Park Department of Public Health received notification of the following new COVID-19 cases:

Date	# of Cases	Age of Cases
December 22 <sup>nd</sup> (Tuesday)	10	<20 to 60s
December 23 <sup>rd</sup> (Wednesday)	12	<20 to 70s

Excluding individuals for which street addresses are not yet determined, the State of Illinois reports a total of two thousand and thirty-four (2034) Oak Park COVID-19 cases. It is important to note that as patient tracking and case follow-up occurs, individuals listing the number of Oak Park cases reported may change depending on residency confirmation.

The Oak Park Department of Public Health is notified of positive tests as established by state and local public health protocol. Because of privacy laws, no additional information can be released about the individuals. It is noted, that privacy precludes location information regarding individuals tested to anyone other than Public Health Officials and First Responders.

The Oak Park Department of Public Health is working closely with officials from the Illinois Department of Public Health (IDPH), investigating and notifying anyone who may have had exposure to the individual who tested positive for COVID-19. Local public health officials, hospitals and first responders are following protocols consistent with the latest guidance from the Centers for Disease Control and Prevention (CDC).

# **COVID-19 Vaccines**

For current vaccination information visit the Village website at www.oak-park.us/covidvaccination. The Oak Park Department of Public Health received 975 doses of vaccine manufactured by Prizer yesterday and 300 Moderna doses today. This week's limited supply has been allocated in its entirety to Rush Oak Park Hospital, West Suburban Medical Center, PCC Wellness Center – a Federally Qualified Health Center (RQHC) for frontline healthcare worker serving these facilities, and the Village of Oak Park for Phase 1a qualified paramedics of the Oak Park Fire Department and forward facing Point of Dispensing (POD) healthcare workers that will be staffing VOP PODs (which will begin when sufficient vaccine supply is available) in accordance with state and federal guidance. Information on how residents who qualify under Phase 1a – and are not being vaccinated through a hospital affiliation – can schedule a vaccination will be provided on the Village website after on or about January 1, 2021.

# Cases related to Long-Term Care and Assisted Living Facilities

Interim Public Health Director Terry reported today the forty-sixth death of an Oak Park resident believed to be related to the COVID-19 coronavirus. The fatality is a 78-year-old female residing at one of our long-term healthcare facilities. Director Terry expresses his sincere condolences to the residents' friends and family for the loss of their loved one.

# Public Health Data

Interim Public Health Director Terry has shared the following data related to COVID-19. "New cases per 100,000 People". This metric looks at the number of recent COVID-19 cases per 100,000 people to describe the potential number of people who are currently ill and may be infectious. This is the number of new cases reported by IDPH in the previous week. Calculated as a rate = [Village of Oak Park case count for 7 days] / [Village population] x100,000.

- Oak Park rate: 187/100,000
- Cook County rate: 482/100,000 (12/06/2020 through 12/12/2020)
- Target for County-level data: Cases for the week are fewer than 10 or the rate is fewer than 50 cases per 100,000 people
- Warning for County-level data: New case rate is greater than 50 cases per 100,000 people




