She ended her presentation by providing some ideas for the 2017 work plan including second-hand smoke, mental health, nutrition, physical activity and obesity, tobacco, expanding chronic disease, developing criteria for Fitzsimmons awards and increasing information on the Village webpage. The Board of Health reviewed, updated and then voted to approve the 2017 Work Plan, first by Vesga, second by Rogers.
