**Public Hearing(s); Sitting as the Design Review Commission**: The Applicant, AH Oak Park, LLC, requested a variation from Section 7-7-15 (D) (5) of the Village of Oak Park Sign Code, that requires signage be located on the sign freeze or the sign band of the building immediately above the first floor window and below the second floor window sills to install an "American House" sign on the fourth floor level above the main entrance at the premises commonly known as 703 Madison Street, Illinois, Property Index Number 16-18-201-032-0000 ("Subject Property").

Village Planner Failor provided an overview of the application and reviewed the staff report. He indicated staff's support for the sign and reminded the Commission of previous approvals for similar signage for single occupant buildings in downtown Oak Park and along Madison Street.

The Commission began stating comments and asking questions of the applicant. The applicant was represented by Mr. Alan Coy with Redico. The Commission ask for the reasons for the proposed location of the sign at the fourth story. Mr. Coy indicated that the location was positioned over the entry to the facility along Madison Street. His associate mentioned that the height of the surface at the fourth floor was able to accommodate the 4-foot-tall by 10-foot-wide sign better than the second or third floors. Questions were asked if the applicant review other locations on the building for the signage. The applicant had looked at other options but decided the proposed location is best. The Commission inquired as to the location of street trees and potential blockage of lower level areas for signage. It was stated by the applicant that this sign is the only major signage on the entire building.

Commissioner Kirk made a motion to approved the wall sign as proposed. Commissioner Kuhn seconded the motion. A roll call was taken and the variance approved as follows:
