# 6. <u>New Business</u>:

# A. Application of Sistar5, Inc., DBA Rustico, for Issuance of a Restaurant Class B-4 Liquor License at 155 S. Oak Park Avenue

Annabel Medina appeared on behalf of the applicant, Rustico Mediterranean Fusion. The restaurant is moving from its current location at 722 Lake Street to 155 S. Oak Park Avenue. The new location has a refreshed interior and expanded seating capacity. There is no plan to change the alcoholic beverage options from what is now being served. Staff has been trained on proper procedures for serving alcohol. 722 Lake Street will reopen with a new concept (possibly under a new limited liability company).

A motion was made by Member Emily Masalski to approve the application of Sistar5,

Inc., DBA Rustico, for issuance of a Restaurant Class B-4 Liquor License at 155 S. Oak Park Avenue. Member Kratz seconded the motion.

# B. Application of VFJ Enterprises II Inc., DBA Chicago's Home of Chicken & Waffles, for Issuance of a Restaurant Class B-2 Liquor License at 543 Madison Street

Tanya Van Dyke Johnson appeared on behalf of the applicant, Chicago's Home of Chicken & Waffles. The restaurant opened in Oak Park in December of 2010.

The restaurant currently has a Class B-6 Liquor License (bring-your-own beer or wine). Customers have been requesting service of beer and wine. If approved, the restaurant will offer a limited selection of beer and wine. There will be no active bar and all alcohol service will be tableside.

All restaurant servers and management staff will undergo BASSET training.

A motion was made by Member Kuna to approve the application of VFJ Enterprises II Inc., DBA Chicago's Home of Chicken & Waffles, for issuance of a Restaurant Class B-2 Liquor License at 543 Madison Street. Member Kratz seconded the motion.

These businesses include Kalamata Greek Cuisine, Inc., DBA Kalamata Kitchen, LMP Services, Inc., DBA Courageous Bakery, Jambal, Inc., DBA Sagano Sushi, Buzz Café, Inc., DBA Buzz Café, Thai Neighbor and the Oak Park Arts District Business Association. In addition, Salerno's Pizza and Pasta of Oak Park, Inc., DBA Salerno's Pizza is in the wrong license class and will be moved from B-1 to B-4. Nando's of Oak Park, LLC, DBA Nando's Peri-Peri is also in the wrong class and will be moved from B-4 to B-2.

A motion was made by Member Masalski to amend the code with the edits suggested by Village Attorney Stephanides for presentation to the Village Board. Member Kuna seconded the motion. AYES: Kratz, Masalski, Kuna, Corbin NAYS: None

The motion was adopted.

June 2023 Renewals - Taco 76 is past due with taxes.
