

**Village of Oak Park  
Environment & Energy Commission (EEC) – Meeting Minutes  
August 7, 2018**

**Call to Order:** 7:10pm – The July 11, 2018 meeting of the Village of Oak Park Environment & Energy Commission (EEC) was called to order.

- Mindy Agnew distributed the agenda and minutes. Minutes were reviewed and discussed by the committee members.

**Agenda Item: Chairperson’s Report**

- Chairperson Nick Bridge provided a recent update on talking with D97 and D200 representatives about prospective renewable energy options for the schools. No plans in the near future were under consideration.

**Agenda Item: Disposable Straws**

**PUBLIC COMMENT:** Beverly Graham of the League of Women Voters addressed the Environment and Energy Commission with information about the plastic straw reduction initiatives and meetings they have undertaken locally with cooperative businesses. Beverly offered continued assistance and collaboration in moving this issue forward in the Village of Oak Park.

- Commissioners Stephen Morales and Elizabeth Judson discussed general research on what other communities have done. Stephen provided an overview of a general outline of recommendations to the Village Board created from feedback based on meetings with active community contacts on the subject.

**MOTION:** Stephen Morales presented a motion for staff to request an agenda item for the EEC to present a full report of recommendations to address disposable straws. Commissioner Alvarez seconds the motion. No further discussion. Motion carries.

**Agenda Item: LED Streetlights Survey**

**PUBLIC COMMENT:** Stasia Jamell, longtime resident of Oak Park addressed the EEC with concerns about Blue Light Spectrum choices, and presented hard copy research facts to the EEC Chair about the LED lighting.

Chairperson Nick Bridge presented an update on conversations he and a local lighting expert had with Public Works staff about additional lighting options and prospective sample installation and cost.
