NARRATIVE: THE VICTIM WAS BEHIND THE COUNTER WHEN 4 M/B'S AND 3 F/B'S 20'S ENTERED THE STORE. OFFENDER M/B 20'S THIN BUILD LSW A RED/BLACK HOODED JACKET WITH WHITE SLEEVES AND NUMBER "8" ON THE SLEEVES AND THE BACK CAME BEHIND THE COUNTER AND STRUCK THE VICTIM WITH A PIECE OF ALUMINUM FROM THE GRILL. THE VICTIM THEN HIT THE OFFENDER BACK AND A FIGHT ENSUED. THE OTHER 3 M/B'S THEN BEGAN STRIKING THE VICTIM WITH CLOSED FISTS KNOCKING OVER THE COUNTER. ALL THE SUBJECTS FLED THE STORE AND ENTERED TWO VEHICLES A WHITE NEWER MODEL NISSAN AND A BLACK SUV. DURING THE BATTERY THE OFFENDERS DAMAGED THE POS SYSTEM, SALES COUNTER, CEILING AND THE LOTTERY MACHINE. TOTAL DAMAGE IS UNKNOWN.
