WERE SITTING IN THE REAR OF HIS GREY 2021 HONDA INSIGHT AND WHEN THE VICTIM
STOPPED, #1 EXITED THE REAR DRIVER SIDE, OPENED THE VICTIM'S DOOR AND
ORDERED THE VICTIM FROM THE CAR. OFFENDER #1 INDICATED THAT HE HAD A GUN
UNDER HIS HOODIE. SUBJECTS #2 AND #3 GRABBED THE VICTIM FROM BEHIND UNTIL
HE EXITED THE VEHICLE. THE SUBJECTS FLED IN THE VICTIM'S VEHICLE E/B ON
JACKSON FROM LYMAN. LOSS \$30,000.
