WAS TAKEN INTO CUSTODY IN 700 BLOCK OF S ELMWOOD AFTER HE DROPPED A BLACK HANDGUN TO THE GROUND. VICTIM IDENTIFIED ABOVE JUVENILE AND THE WEAPON AS THE ONE POINTED AT VICTIM. THE WEAPON WAS FOUND TO BE A BLACK BB GUN. INVESTIGATION RESULTED IN A POSITIVE IDENTIFICATION OF SUBJECT WITH THE WEAPON, BUT VICTIM WAS UNABLE TO IDENTIFY THE OTHER TWO JUVENILES. THE ONE JUVENILE OFFENDER WAS SUBSEQUENTLY CHARGED WITH AGGRAVATED ASSAULT AND BATTERY, AND THE OTHER TWO JUVENILES WERE RELEASED WITHOUT CHARGES. THE ARRESTED CHICAGO JUVENILE WAS LATER TRANSPORTED TO 1100 S HAMILTON.

OFFENDER IS CHARGED WITH 2 FELONY COUNTS OF AGGRAVATED DOMESTIC BATTERY, ONE COUNT KIDNAPPING WITH FIREARM (FELONY), DOMESTIC BATTERY (2 MISD COUNTS) AND INTERFERENCE WITH REPORTING-DOMESTIC VIOLENCE (1 COUNT).
