AGENDA

It was moved and seconded to approve the agenda for the meeting. A voice vote was taken and the agenda was approved as presented.

MINUTES

It was moved and seconded that the minutes of the Special Meeting of June 28, 2010 and the Regular Meeting of October 4, 2010 be approved. A voice vote was taken and the minutes were approved as presented.

Village Clerk Teresa Powell announced the hours for early voting at Village Hall, which will be held through October 28.

Mark Twain Month in the Village of Oak Park October 2010

It was moved and seconded to concur in a Proclamation to recognize October, 2010 as Mark Twain Month in the Village of Oak Park. President Pope read the Proclamation aloud. A voice vote was taken and the Proclamation was adopted.

PRESENTATION

Paul Zimmerman, Roosevelt Road Business Association

President Pope introduced Paul Zimmerman, President of the Roosevelt Road Business Association (RRBA). Mr. Zimmerman spoke about the International Economic Development Council, which presented the award to the RRBA in the category of Regionalism and Cross Border Collaboration . He recognized the elected officials and volunteers from the communities of Oak Park, Berwyn and Cicero who played a role in receiving this honor.

VILLAGE MANAGER REPORT

A. Village Manager Tom Barwin stated that construction in the Village was coming to an end for the year. Work on East Avenue from Roosevelt to Garfield continues. The first layer of asphalt was corrected and the final surface should be completed this week.

Mr. Barwin announced that Halloween Trick or Treat Hours were from 3:00 p.m. to 7:00 p.m. on Sunday, October 31. He relayed the Fire and Police Departments' recommendation that parents accompany their children, especially after dark.

He asked that residents adhere to the safety guidelines, which is to keep leaves on the parkway side of the curb until one or two days before collection.

D. First Reading of an Ordinance Amending Chapter 12, Article 1, Section 7-1 and 7-2 of the Village Code to Decrease the Minimum Required Daily Temperature and to Shorten the Heating Season

Trustee Johnson clarified that comparisons to neighboring communities, including Chicago, were made regarding temperature control. This amendment would lower the daytime required temperature to 68 degrees. The current nighttime required temperature would remain at 64 degrees.

- Trustee Johnson expressed concern regarding the recent youth suicides across the country resulting from lesbian, gay, bisexual and transgender bullying. He requested support from the Board to work with staff in creating a YouTube video in collaboration with the OPRF Gay Straight Alliance that offers support and a positive message.
- Trustee Lueck added that this is a very personal and serious matter, and although there have been no incidents to this degree in Oak Park, it does not mean that this type of bullying does not occur. She commended the OPRF HS Video Department and was confident this was a great opportunity to partner with them to advance something crucial and critical to their vision of Oak Park as a community. She spoke about her term on the Plan Commission when the Roosevelt Road Plan was developed and also asked how the Seven Generations Ahead survey was being promoted.
- Village Manager Barwin announced that in addition to the award discussed this evening, the Wright Historic District was named one of the nation's Top Ten Great Neighborhoods.
- President Pope stated that in the upcoming weeks, there will be opportunities to read up on the various candidates running for office and encouraged residents to become educated on the issues and to vote.
